NOTICE OF RACE

- 1. RULES:** All MMYC Series will be governed by the Racing Rules of Sailing, as modified by Appendix E regarding radio sailing, the Sailing Instructions ("SI"), and the DF95 Restricted Class Rules. In case of any conflict between this NOR and the associated SI, the SI will take precedence.
- 2. ELIGIBILITY:** All MMYC Series are open to any skipper sailing a boat that is compliant with the DF95 Restricted Class Rules. Being a dues-paying member of MMYC will make you eligible for inclusion in the final series standings. Membership in the AMYA is encouraged.
- 3. REGISTRATION:** Advance registration is not required. Any skipper intending to race need only arrive at the designated venue on race day.
- 4. SCHEDULE:** MMYC will conduct four (4) DF95 Seasonal Series in 2026. Each Series starts on or after the change of the season. Each Series will consist of no more than eight (8) race dates. Racing will take place on Sundays most of the year, but on Wednesdays between Memorial Day and Labor Day, except for Sunday races on June 14, 2026, and July 19, 2026. Open practice sessions precede racing by one hour. A complete race schedule is available [here](#). Prior to each race, an email to the MMYC Mailing List and posting on the MMYC Facebook page ([here](#)) will confirm time and location of each race.
- 5. CANCELLATION OR RESCHEDULING:** Notice of any cancellations, postponements, venue changes, or time changes will, to the greatest extent possible, be distributed at least 24 hours in advance by email to the MMYC Mailing List and posting on the MMYC Facebook page. 6. START AND FINISH TIMES:

- 6.1 On **Sundays** in the **Winter Series**, heats start as soon as possible after (but no earlier than) 1300, and end by approximately 1430. On **Sundays** in the **Spring Series** and **Summer Series**, heats start as soon as possible after (but no earlier than) 1400 or 1630, depending on the race date, and end by approximately 1530, 1600 or 1800. On **Sundays** in the **Fall Series**, heats start as soon as possible after (but no earlier than) 1300 or 1400, depending on the race date, and end by approximately 1430 or 1530. - 6.2 On **Wednesdays** in the **Spring Series** and **Summer Series**, heats start as soon as possible after (but no earlier than) 1630, and end by approximately 1800. A complete schedule showing all start and finish times is available [here](#).
- 6.3 The Race Director will start as many heats as possible within the allotted 90 (or 120) minutes and may, at his discretion, extend racing beyond that time only with the consent of all competitors still present when the allotted time expires. All start and finish times are subject to change by announcement from the Commodore, Vice Commodore, or Race Director.

7. VENUES:

- 7.1 The **Camden Public Landing** is located at the foot of Commercial Street in Camden, Maine ([Public Landing](#)). We typically race from the dock directly in front of the restaurant called Peter Ott's. Parking in the public lot near the Harbormaster's office is available on a first come, first served basis.
- 7.2 The **Tennyson Pond** venue is on private property located at 215 Cedar Street in Rockland, Maine ([215 Cedar St](#)). Parking is along the northeast side of Cedar Street. Please latch the gate upon entering and leaving so as not to let the dogs out.
- 7.3 The **Lake St. George** venue is on private property located at 143 N. Smith Road in Liberty, Maine ([143 N. Smith Road](#)). Instructions on parking will be circulated prior to each race, but carpooling is encouraged.
- 7.4 Alternative Locations may become available. When it becomes necessary or desirable to use them, directions will be circulated by email to the MMYC Mailing List and posting on the MMYC Facebook page ([here](#)).

8. SPORTSMANSHIP AND CORINTHIAN SPIRIT: Above all, remember that we are engaged in a friendly competition in the Corinthian spirit of fair play. We sail for the love of sailing. We race for the fun of racing, but at MMYC events, winning is not everything. Behavior that is deemed to be a breach of RRS Rule 2, or of good sportsmanship, or of good manners, or which may bring the sport into disrepute, will not be tolerated. The Commodore, Vice Commodore, or Race Director can penalize such behavior, including by exclusion from a race or series.
